## GABRIEL MANNARINO ANTI-RACKETEERING

Reference is made to the report of Special Agent Thomas G. Forsyth, III, Pittsburgh, June 18, 1962.

There follows a brief characterization of informants used in referenced report:

- PG T-3 is a physician, whose professional services have, on occasion, been used by members of the MANNARINO organization and who frequents MANNARINO-controlled gambling and after-hours establishments.
- PG T-44 is a Pittsburgh, Pa., businessman who associates with, and is related to, known gamblers in the Western Pennsylvania and West Virginia areas.
- PG T-45 is a numbers racket employee on the North Side section of Pittsburgh, Pa.
