PSI (UD) JOSE DEL CARMEN BAQUEIRO RUZ at Merida was assigned a lead at Carrillo Puerto, Quintana Roo, to attempt to determine if subject is still there. On June 24, 1970, the source advised that due to a trip on behalf of this office to the State of Campeche he had not yet been able to make a trip to the Territory of Quintana Roo.

On July 2, 1970, a source, who has furnished reliable information but contact with whom has been insufficient to fully judge his reliability, furnished the following information:

Inquiry at Carrillo Puerto, Quintana Roo, Mexico, revealed that the subject is not there. Residents reported that DAVID JERTSEN, from whom the subject had been renting a hut, had gone to Chetumal, the territorial capital.

HECTOR LAZARO MARTINEZ, Chief of the local office of the Mexican Immigration Service, Chetumal, advised he knew of the subject but had had no news of him for quite some time. He said he could not furnish the subject's current whereabouts. (S-1)(u)

Efforts to locate DAVID JERTSEN in Chetumal developed that he had gone to Merida, Yucatan. A recheck at Carrillo Puerto revealed that JERTSEN was selling his holdings in that town. (S-1)(u)

DAVID JERTSEN was located at the Hotel America in Merida, Yucatan. He stated that the subject had lived with him in Carrillo Puerto during approximately the last three
