Enclosed herewith for the Bureau are four copies of a letterhead memorandum and one copy for the Detroit Office concerning the activities of subject HOFFA on 9/19, and the morning of 9/20/61.

The first confidential source referred to in the enclosed letterhead memorandum is WILLIAM BURNS who is President of the Rebel Teamsters Union, Chicago, and also a member of Local 710, IBI, who was contacted by SAA RONALD S. FOSBURG on 9/19/61. BURNS was at the Shoreland Hotel presenting grievances to the Board hearing such grievances. He reported his grievances were thrown out by the Board which he claims HOFFA runs with an iron hand.

A second confidential source referred to in the enclosed letterhead memorandum is WALTER A. REED, Manager of the Shoreland Hotel, who was contacted by SA GEORGE H. GRIFFIN on September 20, 1961.

Investigation at Chicago continuing to further identify individuals meeting with HOFFA at the Shoreland Hotel.
