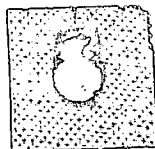
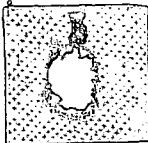

Re: Airtel 9/23/62 with enclosure captioned "Mechanismo
Reorganizacion Revolucionaria (MIR)" which contains information
concerning captioned group.

Enclosed for each office is copy of Army report dated
9/24/62. No report of captioned organization was located in
Bufile.

With reference to statement in paragraph two, page
one, of attached report, that the information will not be passed
to any agency outside Department of Defense or CIA, Army advised
on 10/5/62 it had no objection to inclusion of the information in
reports prepared for dissemination to State, Central Intelligence
Agency, Intelligence and Information Services and other
interested agencies.

San Juan immediately institute investigation to determine
background of captioned group, its strength, source of funds,
identity of leaders, whether it has foreign principal and nature
of its activities. Of particular interest would be any pertinent
information that it has actually undertaken or its plan to
infiltrate 35 armed guerrilla fighters into Cuba. (S)(u)

(2-4) (u) mentioned in attached report should be further
investigation of possible. Roberto does appear identical with
Roberto O. H. ... former San Juan, ... currently MI of San Juan Office.
