SAMUEL M. GIANCANA, AKA. AR. DAILY SUMMARY. CG 6486-C* REPORTED YESTERDAY THAT FELIX ALDERISIO, CHICAGO TOP HOODLUM, CONFERRED BRIEFLY WITH DOMINIC BLASI THAT DATE AFTER HAVING ADVISED BLASI THAT HE HAD BEEN ATTEMPTING TO CONTACT HIM ALL OF THE PREVIOUS NIGHT. HE SAID HE HAD RECEIVED A CALL FROM HOFFA RE HAVING A MEETING IN A CITY BELIEVED TO BE EITHER NEW YORK OR DETROIT. MENTIONED THAT IT WAS VERY IMPORTANT THAT GIANCANA CALL TELEPHONE NUMBER JE 8-7959 AT 10 PM LAST NIGHT. PCI GLADYS EBLE ADVISED YESTERDAY THAT DURING THE TIME THE MEETING TOOK PLACE SHE OBSERVED GIANCANA, BLASI AND AN UNKNOWN IN THE VICINITY OF THE ARMORY LOUNGE, FURNISHED LICENSE NUMBERS WHICH PROVED TO BE THOSE UTILIZED BY GIANCANA AND BLASI. SURVEILLANCE MAINTAINED LAST NIGHT NEAR ARMORY, AND CLOSE CONTACT KEPT WITH SOURCE, HOWEVER, GIANCANA AND GROUP NOT OBSERVED. ONLY ACTIVITY IN VICINITY OF SOURCE WAS DINNER PARTY HELD BY UNIDENTIFIED GROUP NOT AFFILIATED WITH GIANCANA. DETROIT ADVISED THERE IS NO EXCHANGE THAT DIVISION AS JE, HOWEVER, NEW YORK DOES HAVE A JE EXCHANGE. ARMED AND DANGEROUS. *u*
