Instant report is being submitted in accordance with Bureau instructions.

Investigation in this matter was predicated upon the receipt of information from EFFRAIN I. KARELL, a former PSI of the New York Office, who at the time he originally furnished information, identified the subject as JESUS GOMEZ Y OROPESA.

Subsequent investigation has ascertained that the subject's correct, last name is GOMEZ-FENTE, and that the above source was in error; therefore, GOMEZ Y OROPESA is not being carried as an alias in instant matter.

JESUS GOMEZ-FENTE was contacted on 2/21/62, in connection with the matter captioned, "CUBA EN ACCION; RA-CUBA" (New York 97-2324) an anti-CASTRO organization, which investigation ascertained existed in name only and which is in a closed status in the New York Office.

GOMEZ-FENTE, at the time he was interviewed, above, advised that he wished to cooperate actively with the Federal Bureau of Investigation, however, he had been unsuccessful in his attempts to join a pro-CASTRO organization.

He is the subject of a closed case in the New York Office captioned, "JESUS GOMEZ-FENTE; PSI - CUBA" (New York 134-7637).

Information concerning the subject's interview by INS was set out in INS report dated 3/26/64, at Newark, New Jersey.

A copy of the enclosed report is being disseminated to INS locally, inasmuch as the subject is a Cuban national.
