Reference is made to your letter dated October 19, 1970,

JFK Act 6 (1)(B)

This agency appreciates the interest which motivated this proposal. We believe, however, that such an operation currently possesses minimal chance of success and, therefore, cannot recommend same. (U)

As you are aware, the [redacted] operation also directed against [redacted] has utilized similar contact with [redacted] since 1968 without success to date. While [redacted] has made no overt gestures [redacted] such as [redacted] his military status and location, coupled with his background, combine to make him a most desirable target for [redacted]

Of yet more significance, insofar as any current approach to [redacted] is concerned, is the recent [redacted] taken by the United States Government against [redacted] both of whom were connected with [redacted]

United States for many months to come, especially those emanating from [redacted] In such an atmosphere, it is felt [S] [redacted] will be regarded with the utmost [S] suspicion for some time to come. (S)

NOTE:

JFK Act 6 (1)(B) [redacted] Operation proposed by OSI closely parallels our [S] [redacted] (OSI code name for [S] TP [S]), a [redacted] airman currently assigned to McCoy Air Force Base, Orlando, Florida. Under our direction, with support of OSI, [redacted] since 1968, has visited and corresponded with both [redacted] in New York City and the [redacted] in Washington, D.C. [S] without attracting the attention of [redacted] The [redacted] refers to the [redacted] on 10/9/70 by U.S. Government [S]

both of whom have been identified by us as [redacted] [S] In response to OSI request for our feelings relative to proposed [redacted] we are going on record as positively [S] opposed to same. (S)

JFK Act 6 (1)(B)

1. (S) [redacted] is the OSI cover name for a [redacted] which has been directed mainly against [redacted] since May 1967. Except for a recent indication from an FBI source that a [redacted] showed an interest in Subject, there has been no positive input to indicate [redacted]. However, intelligence information developed by your agency has showed that [redacted] displayed intelligence interest in [redacted] at least two Air Force bases in Florida, MacDill AFB and Homestead AFB.

JFK Act 6 (1)(B)

2. (S) In view of the known [redacted] in the above bases, the apparent future of the [redacted] and the present lack of any viable operation involving USAF assets, we would like to determine your feelings concerning initiating an induced operation against [redacted]. We believe that a young, low ranking airman, [redacted] who is or could be in the future stationed at Homestead AFB or MacDill AFB would fit our purposes. The asset, [redacted] considerations, [redacted]. A more detailed scenario would be developed once an asset is identified and recruited.

3. (S) The objectives of this operation would be to determine [redacted] as they apply to USAF installations, the degree of cooperation between [redacted] and the techniques the [redacted]
