Enclosed herewith for the Bureau are two Xerox copies each of a leaflet captioned "Special Bulletin" and a leaflet captioned "Kennedy Assassination". One Xerox copy of each is enclosed for Kansas City.

The two leaflets were furnished on 3/25/64 by PSI WILLIAM CREEDEN who received them on that morning from ERNEST MOORE, 174 Devon Street, Kearny, N.J., described by CREEDEN as evidently a leader of the "MINUTEMEN" in the Newark area. CREEDEN pointed out that MOORE did not give him the sheet concerning security measures referred to in the next to last paragraph on page 2 of the "Special Bulletin". CREEDEN should be described as a source with whom insufficient contact has been had to determine his reliability.

Inasmuch as CREEDEN stated that the check marks on both leaflets were made by MOORE, it is suggested that in order to avoid compromising the informant these check marks be covered if any further copies of these leaflets are made for dissemination. The originals have been returned to CREEDEN who was instructed to return them to MOORE by the end of the week.
