Source stated on May 28, 1963, that PETER CAVATAIO has a telephone answering service at the Holiday Bread Company and that the service operates on a 24 hour per day bals. Source stated that anytime that the phone at Holiday Bread Company office rings more than five or six times, it is answered at the telephone answering service, which is handled by the Tel-Ans-A-Phone Service, telephone TU 3-3100.

Source advised that PETER CAVATAIO currently has a great deal of contact with PAUL VITALE and that they meet generally at Carson's Restaurant on Woodward between 12:00 and 12:30 in the afternoon. Source stated that CAVATAIO is extremely worried over the possibility of grand jury action in connection with the case involving CHUCKY O'BRIAN and SAM FINAZZO in the theft of material from the United States Customs Warehouse at the Earbor Terminal.

Source stated that one JOE CORRADO, who is a distant relative of DOMINIC and TONY CORRADO, was recently hired as a truck driver by CAVATATO at the Holiday Bread Company. Source stated that this CORRADO drives a silver blue convertible automobile.

Source advised that a meeting was held at the Holiday Bread Company on April 24, 1963. Source stated that the meeting was attended by PETER CAVATAIO, DOMINIC CAVATAIO, SAM FINAZZO, RYMIE HASTMAN, HAROLD FINE, TONY and VITO GIACALONE, and two individuals whom Source did not know, who arrived by air in Windsor, Canada. Source stated that SAM FINAZZO drove to Windsor to pick them up and he met them at the office of a travel service in Windsor, operated by a father and son. Source did not know either of these individuals, but did identify them as follows:

- 1. 6' 2", well built, about 50 years of age, very well dressed, tan complexion, with neat and well ground salt and pepper hair.
  - 2. 5' 9", well dressed, about 50 years of age, and dark, hard looking.

Source advised that PETER CAVATAIO currently has a \$40,000.00 law suit pending against him, instituted by Margo Bakery in Canada, where CAVATAIO formerly purchased bread.

Source advised that CAVATAIO is currently getting established in the juke box and cigarette machine business. Source advised that CAVATAIO is associated with DOMINIC CORRADO in this deal and that they are "muscling" in and attempting to take over and install their machines in places which have heretofore carried machines from other companies.

Source advised that an individual by the name of JOHN MISLISZ or MYSILSZ is currently working with CAVATAIO at Holiday Bread. Source stated that MISLISZ was originally brought to the Holiday Bread Company by PETE VILOPPI, who was associated with CAVATAIO but who is now working with JOE FRANKO of the Teamsters Union.

Source stated that MISLISZ lives in Lincoln Park, Michigan, and that he has been writing bad checks all over Detroit. He writes seven or eight hundred dollars a week worth of bad checks. Source described this individual as 48 to 50 years of age, 6' tall, heavy set, sandy hair, blue eyes, and drives a blue and white Chevrolet.

Source advised that the entire CAVATAIO family is leaving Detroit during the latter part of June to attend BILLY CAVATAIO's graduation from law school in Georgia. Source stated that when BILLY CAVATAIO comes back to Detroit, he is going to work at the Teamsters Union under BILL BUFFALINO. Source stated that JIMMY HOFFA made arrangements for BILLY CAVATAIO to get this job.
