NEV According to SU-283-C there are a number of persons connected with the rackets in Chicago, Camden, N. J., Philadelphia and Pittsburgh, Pennsylvania, who associated with garg controlled by REGENELLI, GUZIK and ARCADO that were recently in Las Vegas when it appeared that the sale of the Last Fronties Hotel would be completed and they were placed in the hotel to familiarize themselves with its overall operations.
