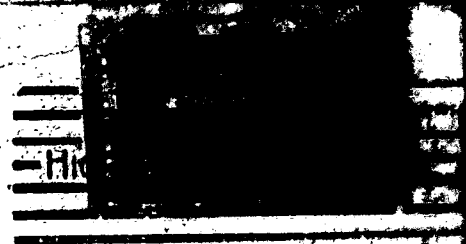

Dear Mr. Schlichting:

I have delayed a little in answering your letter of May 30th, in the hope that the art books which you mention as being sent to me would arrive. They have not yet appeared, but the delay is natural enough, and I look forward most eagerly to receiving them. I read German very badly, but will be able to study them with the help of friends-- and will certainly do so.

As for terms for the translation and publication of "THEORY AND TECHNIQUE," I shall be glad to have it done on the same terms as for "FILM IN THE BATTLE OF IDEAS." I believe the publishers of the latter (Masses & Mainstream, 832 Broadway, N. Y.) made a proposal regarding terms. I regret to say that I am very vague about the actual figures that were suggested. In any case, I am agreeable to any arrangement that is customary and proper. If you will suggest whatever the German publisher feels is a fair offer, ~~which~~ and in accord with general procedure for a work of this type, I am sure it will be satisfactory.
