On October 14, 1970, Mr. LUIS KUTNER, 2330 Bankers Building, Chicago, known to the Bureau as Counsel for WUFF, (refer to Bufile 105-205074, May 18, 1970, regarding ERIC LIN, DIA Representative) telephonically contacted this office. KUTNER advised he feels Mr. PING Ming-min, who is in the United States by visa with the knowledge of the State Department, and who is teaching at Ann Arbor, Michigan, is in danger in that he escaped from a jail in Formosa, and is considered a fugitive by the Formosan authorities. Protection for PING was requested by KUTNER.

KUTNER was informed the FBI does not furnish protection for people and if he has reason to believe PING is in danger, he should contact the local police in Ann Arbor.

Chicago is aware of PING's identity as a leader in the Taiwan Independence Movement and of his escape from Formosa to Stockholm and eventual entry into the United States.

It appears KUTNER is attempting to make the FBI aware of PING's presence and situation in an effort to forestall any activity by the Chinese Nationalists to intimidate PING.
