CHILEAN POLITICAL OPGANIZATION KNOWN AS "PATRIA Y LIBERTAD"

(FATHERLAND AND LIBERTY). BOSCH STATED THAT ORLANDO LETELIER'S
DEATH WAS THE RESULT OF AN AGREEMENT BETWEEN GUILLERMO NOVO
AND THE PATRIA Y LIBERTAD ORGANIZATION. SOU

LEGAT, CARACAS, ADVISED IN A TELETYPE NOVEMBER 4, 1976, SOU

THE LEGAT, AT THAT TIME, HAD NO IDEA WHAT WAS MEANT BY THE

COMMENT THAT PEMBERTO WAS THE INDIVIDUAL "BEHIND EVERYTHING," CHICS

BUT SUGGESTED THAT MORALES WOULD PRORABLY COME TO MIAMI AND THAT CUI

THE MIAMI OFFICE COULD, IN FACT, OBTAIN THE DETAILS DESIRED

FROM MORALES.]

THE POSSIBILITY CLEARLY EXISTS THAT THE INFORMATION AVAILABLE ON MOPALES MAY, IN FACT, IN SOME WAY TIE IN WITH CUINFORMATION RECEIVED BY MIAMI FROM ANOTHER HIGHLY PLACED SOURCE, THEREBY INCREASING THE IMPOPTANCE OF THE INTERVIEW WITH MOPALES. (X) CUI

WHILE THE MIAMI OFFICE HAS INDICATED THAT THEIR RELATIONS WITH MOPALES HAVE BECOME SOMEWHAT STRAINED, THERE IS NOT CY

INDICATION THAT THE LIAISON BETWEEN MORALES AND CARACAS LEGAL CUI ATTACHE JOE LEO HAVE BEFN IMPAIRED. THE WASHINGTON FIELD OFFICE FFELS THAT THE IMPORTANCE OF THE INTERVIEW OF MORALES CANNOT BE UNDERESTIMATED SINCE RECEIPT OF INFORMATION FROM "WILDCAT"; AND, THEREFORE, THE BUREAU IS PEQUESTED TO ASK LEGAT, CARACAS, TO ATTEMPT TO ESTABLISH CONTACT WITH MORALES AND ATTEMPT TO OBTAIN DETAILS OF COMMENTS PREVIOUSLY MADE BY MOPALES TO LEGAT.

IN VIEW OF THE POSSIBILITY THAT (MORALES) CAN BE CONTACTED

AND INTERVIEWED BY THE LEGAT AND BECAUSE OF THE EXTREMELY

SENSITIVE NATURE OF THE CONTACT, WASHINGTON FIELD IS HOLDING

IN ABEYANCE ANY CONTACT WITH THE STATE DEPARTMENT REGARDING

THIS MATTER UNLESS ADVISED TO THE CONTRARY BY THE BUREAU

IN COMPLIANCE WITH BUREAU INSTRUCTIONS, ASSISTANT UNITED STATES ATTORNEY (AUSA) FUGENE M. PROPPEP, MAJOR CRIMES UNIT, UNITED STATES ATTORNEY'S OFFICE, WASHINGTON, D.C., WAS CONTACTED ON THE MORNING OF DECEMBER 3, 1976, AND ADVISED THAT THE FEDERAL BUREAU OF INVESTIGATION'S (FBI'S) DESIPE TO HAVE NO FUPTHER CONTACT WITH MORALES NAVARRETE UNTIL (**)

AFTER THE COMPLETION OF THE TRIAL OF OPLANDO OTERS IN FLORIDA ON VARIOUS LOCAL BOMBING CHARGES. PROPPER STATED THAT HE WAS UNABLE TO SEE THE MECESSITY FOR DELAY IN THE INTERVIEW OF MORALES NAVARRETE SÍNCE THE INTERVIEW WOULD BE CONFINED SOLELY TO THE FACTS IN THIS MATTER AND WOULD IN NO WAY JEOPARDIZE THE OTHER CASE PENDING IN LOCAL COURT. PROPPER INQUIRED SPECIFICALLY WHETHER THE FBI WAS AWARE OF MORALES' PRESENT WHEREABOUTS AND STATED THAT HE COULD NOT UNDERSTAND THE RELUCTANCE OF THE BUREAU TO HAVE NO CONTACT WITH HIM UNTIL AFTER THE TRIAL. PROPPER WAS THEN ADVISED OF THE NATURE OF THE FRI PELATIONSHIP WITH MORALES AND THE PROBLEMS THAT HAD ARISEN IN CONNECTION WITH HIS TESTIMONY IN THE FUTURE TRIAL REGAPDING ORLANDO OTERO. HE WAS ALSO ADVISED THAT THE FBI WAS CURPENTLY AITEMPTING TO EFFECT AN INTERVIEW OF MORALES ELICIT THE DESIPED INFORMATION IN THIS MATTER.

AUSA PROPPER ALSO ADVISED THAT WHILE THE VENEZUELAN GOVERNENT HAD REFUSED TO ALLOW UNITED STATES OFFICIALS TO BT
