friend, NANCY CZAR, moved from ROSELLI's apartment sometime during the latter part of June, 1965, and no longer lives there. Informant has no knowledge that any other woman is living at ROSELLI's apartment at the present time.

On the afternoon of 7/16/65 information was received from the LAPD that ROSELLI left Los Angeles for Las Vegas at about 3:00 PM on this date via Western Airlines. ROSELLI was alone.

LA 4145-C advised on 7/15/65 that ROSELLI had recently contacted AL PARVIN who owns a considerable interest in the Dohrman Hotel Supply Company for the purpose of convincing PARVIN to have the Dohrman company purchase more refrigeration equipment from Ajax West Coast Corp. FRANZ BREITLING, a close friend of ROSELLI, is president of Ajax and ROSELLI purchases refrigeration equipment from the company for resale. According to informant, BREITLING met with PARVIN on 7/13/65 to discuss this matter. PARVIN was willing to buy more equipment from Ajax but was not certain that he had sufficient control in the company to persuade the buyers to use Ajax equipment exclusively because in many instances other makes of equipment would be However, PARVIN and BREITLING will continue to work on this matter. Informant said that when some agreement is reached between them, ROSELLI will receive a three per cent commission of the gross sales made by Ajax to the Dohrman Informant estimated that if Ajax got all of Dohrman's refrigeration equipment business the total yearly sales would be about \$500,000.
