6. Richard Ralph Davis - Date of birth: 9/9/34 in New York City, New York. Lived in Cuba from age two until 1/12/61 when he returned to U.S. Organized training camp at Lacombe, Louisiana, in the summer of 1963 with anti-Castro Cubans aligned with the MDC.


7. Victor Dominador Espinosa Hernandez - Arrested on McLaney property at Lake Ponchartrain on July 31, 1963 at which time cache of illegal arms was confiscated.
8. Ramon Font Samuell - Chief of Operations of Comandos L. Believed to be serving 30-year sentence for Cuban revolutionary activities in Cuba.
9. Eloy Gutierrez Menoyo - Member of SNFE, which joined with Antonio Veciana's Alpha 66 group in 1962.
10. Victor Paneque aka Captain Diego - Military leader of Cuban group known as MIRR. Raised in Las Villas Province, Cuba. Associated with Orlando Bosch and Frank Sturgis (Fiorini).
11. Alberto Hernandez Hechevarria aka Alberto Fernandez - Former boat captain on Tejana III. Associated with Unidad Revolucionaria.
12. Jose Antonio Lanusa - Provided information to FBI. Member of DRE.
13. Orest Pena - Owner of Havana Bar in New Orleans. Date of Birth: 8/15/23. Testified before the Warren Commission.
14. Carlos Rodriguez Quesada - Leader in Movimiento Revolucionaria 30 de Noviembre group (30th November). Headed faction called Movimiento Revolucionario Frank Pais. Joined group headed by Dr. Paulino Sierra Martinez.
15. Juan Manuel Salvat Roque - Involved in propaganda and military operations for DRE.
16. Paulino Sierra Martinez aka "Dr. Martinez" - Head of Junta de Gobierno de Cuba en Exilio. Formerly employed with Union Tank Car Co., Chicago. Believed to have been backed by former Havana gambling interests.
17. Carlos Zarraga Martinez - Leader in Cuba Libre group. Affiliated with JURE in 1963. 1963 address: 2954 S.W. 16th Terrace, Miami. Several members of INTERPEN arrested there on June 19, 1963. A cache of arms belonging to Zarraga was confiscated.

Reference is made to your letter of March 22, 1978, requesting information from our Service records relating to seventeen persons of interest to your Committee.

Furnished herewith is information relating to sixteen individuals in the order in which presented:

1. Santiago Juan Alvarez-Rodriguez. File All 865 205 discloses he was born on July 25, 1907 at Los Arabos, Matanzas, Cuba. He had been in the United States as a visitor on several occasions. The American Embassy, Mexico, D.F., Mexico issued him an immigrant visa on August 7, 1959. He entered the United States at Laredo, Texas on September 5, 1959 and was admitted for lawful permanent residence. Subject was given deferred inspection and paroled to May 29, 1961 at Miami on April 30, 1961. He was admitted as a returning resident alien on October 3, 1961. A notice of prevention of departure was served on him by the Miami District Office on March 30, 1963. Subject applied for relief from the notice of prevention of departure on June 11, 1964. On June 12, 1964 the Miami District Office temporarily lifted the preventure of departure until October 15, 1964. He reentered the United States on October 5, 1964 and was admitted as a returning resident alien on October 6, 1964. He applied for relief from the notice of the prevention of departure on November 3, 1964. There is no evidence this request was granted. He filed Petition for Naturalization No. 46232 in the United States District Court, Miami, Florida, on December 5, 1969. He was naturalized in the same court on September 2, 1970 and issued Certificate of Naturalization No. 9386926. He is the father of Santiago Alvarez-Fernandez, All 866 226.
2. Santiago Alfredo Alvarez-Fernandez. File All 866 226 discloses he was born on June 12, 1941 at Havana, Cuba. He was issued an immigrant visa at the American Embassy, Mexico, D.F., Mexico on October 16, 1959.

He entered the United States at Miami, Florida on October 20, 1959 and was admitted for lawful permanent residence. He departed the United States on October 21, 1962 to participate in a raid on Cuba. He reentered the United States at Key West, Florida on October 28, 1962 and inspection was deferred to Miami. On October 29, 1962 he was admitted at Miami as a returning permanent resident. A notice of prevention of departure was served on subject through his father on March 30, 1963. On April 3, 1963 the Service advised subject through his mother that the notice of prevention of departure was cancelled. On June 11, 1964 he applied for and received a new alien registration card as the original had been lost. Subject applied for and received a reentry permit on March 26, 1968 valid to March 26, 1969. He applied for and received a reentry permit in January 1974 valid to January 29, 1975. He applied for and received a reentry permit on December 6, 1977 valid for one year. He has never applied for citizenship.

3. Luis Balbuena. This individual appears to be Luis Balbuena-Calzadilla, A12 854 523, born at Guantanamo, Cuba, on December 15, 1928. This name was number 7 in your letter of March 7, 1978. His immigration history and background was given in our memorandum of April 4, 1978 addressed to Deputy Assistant Attorney General Robert L. Keuch, Criminal Division, Department of Justice.

4. Bernardo Gonzalez de Torres-Alvarez. File A13 310 536 discloses he was born on March 26, 1934 at Havana, Cuba. The American Embassy, Havana, Cuba issued him an immigrant visa on November 30, 1954. He entered the United States at Miami, Florida, on January 3, 1955 and was admitted for lawful permanent residence. He departed from the United States on February 18, 1961. He was a Bay of Pigs Prisoner. He returned to the United States on December 24, 1962 at Miami and was admitted as a returning resident. He filed Petition for Naturalization No. 39725 in the United States District Court, Miami, Florida, on June 11, 1968. He was naturalized in the same court on November 15, 1968 and issued Certificate of Naturalization No. 9221157.

5. Evelio Duque Miyar. File A12 418 168 discloses he was born January 3, 1927 at Trinidad, Las Villas, Cuba. He entered the United States at Key Colony Beach, Florida, on June 5, 1961 aboard the Cuban boat "Inez Maria". He was not inspected and admitted to the United States. He was apprehended the same day by the Border Patrol. He applied for political asylum. He was granted indefinite parole at Miami on June 9, 1961. Subject left the United States about the latter part of March 1963 and returned to the United States at Miami on April 5, 1963 aboard the vessel "Violin III". He was reparaoled at Opa Locka Detention Center on April 6, 1963. A notice of temporary prevention of departure was issued and served on him on June 20, 1963 at Miami and he was limited in travel to the land limits of Dade County, Florida. He departed again on July 13, 1963 and returned on July 17, 1963. His parole was revoked on July 23, 1963. He was reparaoled on July 26, 1963 under the same conditions as before. Subject applied for permission to go to Puerto Rico on December 3, 1963 allegedly to seek employment there. The request was

denied on December 11, 1963. On April 3, 1966 he applied for advance parole to go to Ecuador to see if he could obtain employment there. This request was denied. He departed the United States on July 20, 1966 and went to Quito, Ecuador, where he failed to get employment. He went to Mexico in December 1966. He reentered the United States at Laredo, Texas on January 2, 1967 by taxi. He entered without inspection. He was granted indefinite voluntary departure at Miami on January 31, 1967. He has never applied for lawful permanent residence.

6. Richard Ralph Davis born September 9, 1934 at New York, New York. We have no Service record relating to this subject.

7. Victor Dominador Espinosa-Hernandez. This individual was listed as No. 7 in your letter dated January 26, 1978. His immigration history and background was furnished in our memorandum of February 28, 1978 addressed to Deputy Assistant Attorney General Robert L. Keuch, Criminal Division, Department of Justice. He was listed as No. 35 in your letter of March 7, 1978. Further reference was made to him in our memorandum of March 29, 1978 addressed to Deputy Assistant Attorney General Robert L. Keuch, Criminal Division, Department of Justice. File A11 871 224 relating to this subject has been requested from the New York District office.

8. Ramon Font-Saumell. File A12 421 129 discloses he was born July 16, 1922 at Santiago de Cuba, Cuba. He entered the United States at Key West, Florida, on March 26, 1961 aboard the "M/V Tejana III". He was granted indefinite parole status on June 22, 1961. At Miami on March 30, 1963 he was served with a notice of prevention of departure and he was required to remain within the land borders of Dade County, Florida. His parole was revoked on December 16, 1963 and he was detained at the Opa Locka Detention Center; he was released and again paroled on December 24, 1963. He applied for permission to move to Puerto Rico in March 1965. On April 7, 1965 he moved to Puerto Rico and was limited to the land limits of Puerto Rico by the Puerto Rico District Office. Subject filed for lawful permanent residence under the Act of November 2, 1966 on June 26, 1968. His status was adjusted to lawful permanent residence at Miami on June 30, 1968. The prevention of departure notice served on subject was withdrawn on February 10, 1977. Subject applied for and received a reentry permit at Miami on February 25, 1977, valid for one year.

9. Eloy Gutterrez-Menoyo. File A10 190 153 discloses he was born on December 8, 1934 at Madrid, Spain. He entered the United States at Key West, Florida, on January 26, 1961 aboard the Cuban Yacht "Consuelo" and applied for admission as a political refugee. At an exclusion hearing held at Hildalgo, Texas, on March 1, 1961 he was ordered to be excluded and deported from the United States. He was granted indefinite parole status on June 6, 1961. He departed from the United States during October 1962. He last entered the United States at Miami, Florida, on April 6, 1963. His inspection was deferred and he was paroled pending

further notice. On June 27, 1963 he requested for Service permission to depart from the United States for Santo Domingo. His application was denied on July 1, 1963. On or about May 2, 1964 subject departed from the United States. He was alleged to have been on several islands in the Caribbean area at various times. The Miami News of January 26, 1965 stated a Havana report claims subject and three of his companions had been captured by Castro forces. This report was later verified. He is still believed to be incarcerated in Cuba.

10. Victor Paneque aka Captain Diego. File All 877 601 relating to Victor Mannel Paneque discloses he was born on September 18, 1918 at Holguin, Cuba. He entered the United States on September 3, 1960 by Coast Guard Cutter after having been transferred from the "S/S Atlantic Seaman" at sea. The "S/S Atlantic Seaman" picked him up from the Cuban "M/V Marlene" at sea. Subject was ordered excluded from the United States on September 27, 1960 and reparaoled indefinitely the same day. Subject filed for lawful permanent residence at Chicago, Illinois on August 22, 1967. His status was adjusted to lawful permanent residence on November 13, 1967. He filed for and received a reentry permit at Chicago on December 13, 1967 valid to December 13, 1968. He applied for and received a reentry permit at Miami on April 29, 1971 valid to April 29, 1972. He filed Petition for Naturalization No. 75792 in the United States District Court, Miami, Florida on February 2, 1973. He was naturalized in the same court on April 4, 1973 and was issued Certificate of Citizenship No. C9758100.

11. Alberto Hernandez-Hechevarria aka Alberto Fernandez. We have no Service record relating to this subject.

12. Jose Antonio Lanusa-Gobel. File All 240 359 discloses he was born on August 11, 1925 at Havana, Cuba. He had been in the United States as a visitor in 1956, 1957 and 1958. He arrived at Miami, Florida, by air on December 10, 1958 and was held for an exclusion hearing as he acknowledged he was an organizer of the "26th of July" movement. He was ordered admitted as a visitor upon posting a \$1500 bond on December 12, 1958. A petition for a writ of habeas corpus was filed with the United States District Court, Miami on December 11, 1958. The petition was dismissed by the court on December 12, 1958. A new petition for a writ of habeas corpus was filed on December 14, 1958 and granted by the court on December 16, 1958. The Service moved the exclusion hearing be reopened on December 16, 1958 and filed an appeal to the Board of Immigration Appeals on December 17, 1958. On January 6, 1959 the Service notified the Board of Immigration Appeals, that subject had departed for Cuba on Flight CCA CUT 605 on January 3, 1959 and concluded he had abandoned his application for admission to the United States. There is no record of his attempting to enter the United States since then.

13. Orest Pena. File C7426151 relating to Orestes Fornicio Pena-Alfonso discloses he was born on August 15, 1923 at Colon, Cuba. He

originally entered the United States at Miami, Florida, on September 18, 1946 and was admitted as a visitor for pleasure. He applied for an extension of stay which was denied on February 18, 1947. He obtained an immigrant visa at the American Embassy, Havana, Cuba on July 5, 1949. He entered the United States at Miami, Florida, on July 11, 1949 and was admitted for lawful permanent residence. At time of this entry he was in the United States Army stationed at Fort Benning, Georgia. He applied for and received a reentry permit in December 1949 valid to December 30, 1950. He applied for and received a reentry permit in March 1954 valid to May 3, 1954. He filed Petition for Naturalization No. 655072 in the United States District Court, Southern District, New York, New York on February 9, 1955. He was naturalized in the same court on May 6, 1955 and issued Certificate of Naturalization No. C7426151, at which time his name was changed to Orest Pera.

14. Carlos Manuel Rodriguez-Quesada. File A12 548 759 discloses he was born at Sante Spiritus, Cuba on September 25, 1930. He originally entered the United States at Elbow Key, Key Largo, Florida on March 3, 1961 aboard the fishing vessel, "Flying Cloud" with four other male Cuban citizens. They were turned over to the Border Patrol. He was paroled on March 6, 1961 to appear at the Miami District Office on March 10, 1961. At an exclusion hearing held on March 7, 1961 he was ordered to be excluded from the United States. He was granted indefinite parole status as a political refugee. He was issued an immigrant visa at the American Embassy, Montevideo, Uruguay on January 26, 1962. He entered the United States at Miami on January 29, 1962 and was admitted for lawful permanent residence. He applied for and received a reentry permit on June 12, 1972 valid for one year. He filed Petition for Naturalization No. 84296 at the United States District Court, Miami, Florida, on January 10, 1974. He was naturalized in the same Court on October 3, 1974 and was issued Certificate of Naturalization No. C9857969 at which time his name was Anglicized to Carlos Manuel Rodriguez.

15. Juan Manuel Salvat-Roque. File A12 421 546 discloses he was born on March 27, 1940, at Sagua la Grande, Las Villas, Cuba. He entered the United States at Miami, Florida on June 30, 1961 aboard the launch "Gloria". On July 3, 1961 he was granted indefinite voluntary departure. He departed the United States and returned as a visitor on June 12, 1962 authorized to remain until July 11, 1962. He later departed the United States. He returned to the United States at Miami on December 10, 1962 and was reentered. Subject was served with a notice of prevention of departure on March 30, 1963 and was required to remain within the land limits of Dade County, Florida. He applied for an amendment of his parole to allow him to attend a meeting at San Juan, Puerto Rico, on May 20, 1963. His application was denied the same day. He applied for and received authorization to visit various cities in the United States, San Juan, Puerto Rico, Costa Rica, Chile, Mexico and Venezuela between June 18, 1963 and May 1965. The restrictions in the Service letter of March 30, 1963 went into effect each time he returned to the United States.

Subject was found in a boat by the United States Coast Guard on April 22, 1965 in Biscayne Bay west of Key Biscayne. The restrictions were lifted on July 22, 1965 to permit him to go to Caracas, Venezuela. He was issued an immigrant visa at the American Embassy, Caracas, Venezuela on July 29, 1965 and was admitted to the United States for lawful permanent residence at Miami, on August 1, 1965. Subject applied for and received a reentry permit on August 5, 1970 valid for one year. He filed an application to file a petition for naturalization at the Miami District Office on June 3, 1975. He had the required preliminary interview on his application on November 21, 1975. The matter has been referred to the Investigations Branch of the Miami District Office where it is presently pending.

17. Carlos Alberto Zarraga. File A12 419 858 discloses he was born November 9, 1923 at Las Villas, Cuba. He entered the United States at Miami, Florida on November 13, 1960 as a nonimmigrant visitor and was authorized to remain until December 30, 1960. He remained beyond that date without authorization. On June 16, 1961 he was granted indefinite parole status. On March 23, 1967 he filed an application for lawful permanent residence under the Act of November 2, 1966. His status was adjusted to lawful permanent residence at Miami, on August 28, 1967. He filed Petition for Naturalization No. 52249 at the United States District Court, Miami, Florida, on April 17, 1970. He was naturalized in the same court on September 2, 1970 and issued Certificate of Naturalization No. 9386944.



He remained beyond his authorized stay. He was issued an immigrant visa at the

American Embassy, Mexico, D. F., Mexico on November 24, 1961. He was admitted to the United States for lawful permanent residence at Miami, Florida on November 29, 1961. He filed a Petition for Naturalization #38,033 in the United States District Court, Miami, Florida on November 22, 1967. He was naturalized in the same court on March 15, 1968 and was issued Certificate of Naturalization No. 9149625.

59. Nofio Pecora born April 25, 1906. File A17 000 188 has been requested from the New Orleans District office.

61. William Robert Plumlee. We have no Service record relating to this subject.

62. Helen Afance Roan aka Helen Afance Cooley, Mrs. Ray E. Cooley, Mrs. Al Hipper, Mrs. Billy Murl Roan, Helen Woods, Helen Holliday, Helen Holly. Maiden name Krainova. She was born February 24, 1930 in Kobe, Japan. File A8 429 858 relating to Helen Cooley has been requested from our San Francisco District office.

64. Norman Rothman aka "Roughhouse", A11 885 359, born December 16, 1914.

68. Sidney Sieband born April 23, 1910 at Chicago. We have no Service record relating to this subject.

71. Frank Sturges aka Frank Attila, Fred Attila, Fred Fiorini, Frank Fiorini, Frank Angelo Fiorini, Frank Angelo Fiorino, Frank A. Fiorini, Frank Anthony Sturges, Frank Bonnell, Frank Campbell, Fred Frank Fiorini. File A11 884 065 discloses he was born Frank Angelo Fiorini on December 9, 1924 at Norfolk, Virginia. His name was changed to Frank Anthony Sturges by a court order of the Circuit Court of the City of Norfolk, Virginia on September 23, 1952. He came to Service attention on January 6, 1960 when he arrived at Miami, Florida from Guatemala and was held for a hearing in exclusion proceedings as to whether he had expatriated himself by serving in the Cuban Air Force.

A Special Inquiry Officer after a hearing in exclusion proceedings in a decision rendered on April 25, 1960, determined the subject had expatriated himself, was an alien and was not in possession of a valid passport and an immigrant visa and was not exempted therefrom.

This decision was based on an authenticated certification by the Secretary of State from the files of the Department of State that the subject, on March 23, 1959, expatriated himself by accepting an appointment in the Cuban Air Force as Liaison Officer between that air force and the United States Air Force, as certified by the American Consul, Havana, Cuba on January 21, 1960.

An appeal from the decision of the Special Inquiry Officer was taken to the Board of Immigration Appeals, Washington, DC, on May 18, 1960. The hearing before the Board was scheduled on June 17, 1960. The Board in an order dated September 6, 1960 remanded the case to the Miami District Office for reopening the exclusion hearing.

The reopened hearing was scheduled for December 8, 1960 at Miami. The Special Inquiry Officer in a decision rendered on March 14, 1961 found the subject not amenable to exclusion as an alien and directed that he be admitted to the United States.

72. Robert James Todd. We have a Service record relating to a Robert J. Todd, born in Canada in 1924, A10 029 908. We are unable at this time to determine whether he is the subject of your inquiry. We have requested this file from our Los Angeles District Office.

73. Joe H. Tonahill. We have no Service record relating to this subject.

74. Irwin S. Weiner. We have no Service record relating to this subject.

75. Abraham Weinstein. We are unable to identify this individual based on the information furnished because of the number of persons with the same or similar names. If we are furnished biographical data relating to this subject, we will be happy to recheck our records.

76. Eduardo Julius Whitehouse, A11 241 940. He was born at Santiago, Cuba on March 14, 1914, to a United States citizen father and a Cuban mother. He derived United States citizenship at birth.

He entered the United States at Port Everglades, Florida on April 10, 1959, in possession of a Cuban passport and a valid nonimmigrant visitor's visa, B-2. He was authorized to remain until April 30, 1959.

On November 12, 1959 he applied to the Miami District Office for a certificate of citizenship. It was determined by this Service that he had expatriated himself by voting in Cuban elections in 1941 and 1944, and his application was denied on February 18, 1960.

An Order to Show Cause in deportation proceedings was issued and served on him on February 26, 1960 for having remained in the United States without authorization.

He was paroled at Miami on February 29, 1960 and left Miami on March 1, 1960 destined to Atlanta, Georgia, to reside there. He was reparaoled at Atlanta on March 3, 1960 and directed not to leave Fulton and De Kalb Counties without the advance written permission of the District Director, Atlanta, Georgia.

At a hearing held in Atlanta on November 2, 1960, he was granted the privilege of voluntary departure from the United States within such period of time and under such conditions as the District Director shall direct. On November 4, 1960 he was granted indefinite voluntary departure. He departed from the United States on or about April 4, 1961.

Subject reentered the United States at New York, New York on September 9, 1961, in possession of an immigrant visa issued to him at the American Embassy, Leopoldville, Congo, on September 1, 1961, and was admitted for lawful permanent residence.

He applied for and recieved a reentry permit at Miami on February 23, 1962, valid to March 5, 1963.

Subject was the beneficiary of Private Bill H.R. 7057 introduced in the 88th Congress on June 13, 1963, by the Honorable Dante B. Fascell, to restore his citizenship. This bill failed to be enacted.

He applied for and received a reentry permit at Miami on December 30, 1963 valid to December 31, 1964. This was revalidated to December 31, 1965. He departed from the United States for Leopoldville, Congo on November 16, 1964. He returned to the United States in May 1965.

Subject filed Naturalization Petition No. 32836 in the United States District Court, Miami, Florida on October 13, 1965. He was naturalized in the same court on November 19, 1965.

Furnished herewith is information relating to the individuals in the order in which requested.

1. W. Guy Bannister -- No information available.

2. Frank Bartes aka Frank Bardes or Frank Barteze. Full name is Francisco Antonio Bartes-Clarens, File A12 552 978, born Cuba on September 14, 1920. He entered the United States in 1957 as a D-2 crewman on an aircraft. He departed from the United States. He last entered the United States on January 4, 1961 and remained without authorization. He was processed as an overstayed visitor on January 23, 1962 and was granted indefinite voluntary departure. His status was adjusted to lawful permanent residence on August 21, 1968. He was naturalized a citizen of the United States at New Orleans, Louisiana on March 5, 1975. The file discloses he was a licensed pilot with no commercial experience. Between 1964 and 1968 he was employed by various local realty investment and insurance companies, with one exception. In December 1965 he received authorized advance parole to return to the United States. He has acknowledged that between December 1965 and February 1966 he was employed as a pilot for the Congolese government, Leopoldville, Republic of Congo, Africa. He applied for and received authorized advance parole to return to the United States on September 28, 1966. He was going to the Bahamas for the Medalion Realty. He was of interest to the F. B. I. in 1963. The records of the New Orleans Police Department, the Jefferson Parish Sheriff's office and the Louisiana State Police have no record of subject. 6. Carlos Eduardo Hernandez-Sanchez. File A12 437 215 discloses he was born in Havana, Cuba on October 15, 1939. He was admitted to the United States for lawful permanent residence on January 25, 1965. The records of the New Orleans Police, the St. Tammany Parish Sheriff's Office and the 21st District Judicial Court, Covington, Louisiana, have no record of the subject.

7. Victor Dominador Espinosa-Hernandez. File A11 871 224 discloses he was born at Matanzas, Cuba, on August 26, 1937. He was admitted at Florida on May 2, 1960. On June 19, 1963 this Service served him with a Notice of Prevention of Departure advising him he was not permitted to depart from the United States until further notice. He has been under investigation by the F. B. I. and the Customs Service. The records of the New Orleans Police, the St. Tammany Parish Sheriff's office and the 21st District Judicial Court, Covington, Louisiana, have no record of the subject. The Louisiana State Police, Baton Rouge, Louisiana advised they have a record relating to a person who may possibly be the subject, under their S.I.D. 863324. This record has been officially requested by the New Orleans District office. Upon receipt it will be forwarded to this office for further transmittal to your office.

8. Lawrence Howard aka Lorenzo Salcedo or Alonzo Escuido. Our Central office indices and the Los Angeles District office have no record relating to this subject.

9. Lawrence La Borde aka John Tebault or Larry La Borde. Our Central office Personnel Section has advised they have no record of an employee by this name. We have a file A12 729 589 relating to a Larry J. La Borde, born at Miami, Florida on September 4, 1911. He was of interest to the F. B. I.

10. Richard Lauchli. Right name Rich Albert Lauchli was born January 23, 1926 at St. Louis, Missouri. We have no record relating to this subject.

During the course of our inquiries we have ascertained that Lacombe, Louisiana is in St. Tammany Parish and the county seat is Covington, Louisiana. We have further found out that the McLaney family owns quite a few parcels of property in the Lacombe area.

The Gerald Patrick Hemming referred to in connection with subjects Roy Emory Hargraves and Lawrence La Borde is known to this Service. File A11 878 820 relating to Gerald Patrick Hemming discloses he was born at Los Angeles, California on April 1, 1937. On November 9, 1961 this

Service served him with a Notice of Prevention of Departure advising him he was not permitted to depart from the United States until further notice.

None of the subject files have been requested since information other than furnished above is third agency material from the F. B. I. or the U. S. Customs Service.

After the selection of the appropriate materials, the CRS project will consist of the following:

1. CRS will prepare an outline consisting of:
  - a. A paragraph summary of each item; and
  - b. A discussion as to how CRS could analyze the items as they relate to motive.
2. CRS will prepare a paper consisting of:
  - a. A description of the types of literature Lee Harvey Oswald was exposed to; and
  - b. A discussion of how these materials may have provided a possible motive for the assassination of President Kennedy.

In coming to such determinations, the researcher should consider the following areas which may appear in the literature:


1. Political assassinations.

In connection with the investigation of the House Select Committee on Assassinations into the death of President John F. Kennedy, I am writing to request your authorization to have the Committee perform sophisticated photographic enhancement and analysis work on relevant frames of the Kennedy autopsy pictures. The enhancement and analysis work involved is critical to the research efforts of the Committee's autopsy and ballistics experts. This determination was made after a meeting between the Committee's photography panel and Dr. Michael Baden, a member of our autopsy panel.

The Committee's present desire is to obtain those original transparencies and pictures that depict the following areas of concern: 1) the President's head; 2) the President's back; and 3) the President's neck. At this time, we expect that our work will be limited to frames 26, 28, 33-34, 38-41, and 44-48 of the photographic autopsy materials contained in the National Archives, but it is possible that some other frames depicting the areas stated above will also become the subject of analysis and enhancement work.

The Committee's intention is to deliver these items, under the supervision of personnel from the National Archives, to the Rochester Institute of Technology, the University of Southern California Image Processing Laboratory, and the Aerospace Corporation of California. Upon delivery, National Archives personnel will remain in constant visual contact with these materials. Each of the organizations performing this work has assured me that none of the scientific techniques they will be utilizing pose any risk of damage to the materials involved. Moreover, because of the sensitivity of these materials, the experts performing this work have been instructed (and have promised) that at no time are any of the frames

involved to be reproduced in their entirety. Instead, in each instance, only the particular area of interest within each photograph will be reproduced. This precaution is designed to avoid the possibility of any unauthorized individual examining a particular frame and recognizing the President. The Committee has also been assured that all of the materials generated by these experts, including intermediate and "waste" products, will be returned to the Committee for proper disposition. All of these materials will go directly from the laboratories involved to National Archives personnel, so that at no time will anyone have possession of any autopsy-related photographic materials in the absence of proper supervision by the National Archives. No action will be taken regarding any of the materials generated by the Committee's analysis and enhancement work without your prior consent.

As the Committee would like to make these materials available on Tuesday, February 28, 1978, to our experts at the Rochester Institute of Technology, we would appreciate a prompt response to this request. Dr. Trudy Peterson of the National Archives has informed me that she will be available on Monday, February 27, 1978, to discuss this issue with you. Her telephone number is 202-523-3132.

Finally, I must apologize for failing to contact you earlier concerning this matter; I hope that you are not inconvenienced by the short notice with which this request is being made. The Commission was discharged by the President upon presentation of its report and delivery of its files to the National Archives. There is no longer any Commission or staff to act concerning your suggestion in your memorandum of November 8, 1966. In my opinion, the former Commissioners and the former staff of the Commission have no more legal standing to ask that they be allowed to examine the photographs and X-ray pictures made in connection with the autopsy of President Kennedy than any other citizens.

Thus, if you or any other citizen desires to examine such materials and can persuade the proper authorities to allow you to do it, that is your right. For myself, I am satisfied with the testimony of the doctors who performed the autopsy and whose statements, in my opinion, were the best evidence of what was seen and heard at the autopsy. In the final analysis, I think our report must stand or fall on the basis of what it contains.



Louis Stokes, Chairman of the Select Committee on Assassinations, requesting permission for access to the papers of Allen Dulles which were left to Princeton. Mr. Ranney and I are members of the committee set up to monitor access to those papers. The third member, Mr. Angleton, is unavailable at the moment but I have no reason to believe that he would differ from the views of Mr. Ranney and myself.

We believe that there is no basis on which our committee should oppose access by the staff of the Select Committee and I have so informed Mr. Wolf, the chief of its legal staff. In return Mr. Wolf agreed to keep me informed as to who would do the review of the papers and, of more importance to us, what they might want to copy for committee records. It is my belief that there is very little in the papers you have that will be truly pertinent to their investigation.

I trust this is sufficient for your purposes.


