Re Bureau airtel dated 1/30/70, instructing Chicago to advise of information developed concerning the recent alleged visit of GIANCANA to the Chicago area. U

No Chicago informant or source was able to provide any information indicating the possibility that GIANCANA visited the Chicago area during December of 1969 or January of 1970. U

Former PCI MARY KAY MC ALLISTER, a neighborhood source in the vicinity of the residence of GIANCANA, which continues to be occupied by his relatives, at 1147 South Wenonah in Oak Park, Illinois, was contacted on several occasions during December and January and advised that she is quite certain that GIANCANA did not visit his residence during this period. U

CG 7016-PC and CG 6687-PC, both of whom were closely associated with GIANCANA, in the leadership of organized crime, advised that they received no indication whatsoever that GIANCANA visited Chicago recently. Both advised that they felt that they would be knowledgeable being current leaders of organized crime here should GIANCANA return to the Chicago area even for a brief visit. Although neither of these PCs has been developed to the point where total reliability is evident, their apparent sincerity in furnishing the above information made it appear that they were sincere in this regard.
