He asked her to call the Barclay Hotel dining room and to advise STANLEY LEVISON that he would be unable to meet him for lunch since he had to prepare for oral argument in court this afternoon.
12:45	PM	OG	William M. James Jr (No cut) Miss BUTCHER called long distance to DORA MacDONALD, Atlanta, Ga., to inquire as to KING's flight number and time of arrival in NYC. MacDonald did not have the info and said she would call back. Also said that it would not be necessary for JONES to meet KING at the airport.

DORA confirms that arrangements have already been taken care of for someone to meet and pick KING up at the airport. DORA indicates she doesn't know the flight number or exact travel arrangements, but that he will call CLARENCE at 11:30 in the morning.
