The IG, Mr Kirkpatrick, will appeal our decision against conversion of the two subjects above, to Gen. Cabell. This is based upon representations to him by both subjects during his visit in Panama.

In the case of subject (1), please check with FBI Liaison and ask them to verify, if possible that he joined the CP at the instigation and with the blessing of Special Agent Edward W. Buckley who was his FBI Case O. When I call for files again, all I will need is the summary of the two cases SE

Bates said that subject was a very valuable informant and all evidence indicated that he joined the CP for patriotic reasons. Mr Helms called a meeting on 19 Feb with representatives of WH and the undersigned to discuss a proposal by the IG that Subject be converted to staff employee.

It was agreed that the issue would depend on how much the fact that Subject had been widely publicized as an FAI informant would effect the flexibility of his use, his cover, and his possible integration into State Dept. I was asked to inquire of State on their policy and was informed they would much prefer not to integrate a subject of this type. — I so informed Mr Helms. — Final action rests between DAPP and IG

Mr Charles Bates, FBI headquarters liaison representative, advised me in strict confidence that he had personally reviewed Subject's FBI file. He said there is no evidence that Subject had any connection with CP activities prior to the time he came to the FBI. At that time he told the FBI that Communists had been pressuring his father to join the CP but that his father had no interest in that sort of thing. Subject told the FBI that he was willing to join the CP if the FBI would let him do so. In accordance with their policy, the FBI did
