1. Enumerate the name of any drug given to Nosenko and the date it was administered -- including those given for "therapeutic" purposes -- from January 1964 to 1968.

2. Describe in detail Nosenko's living conditions from April 4, 1964 through 1968. The description should include, but not be limited to the following:

- a. where he lived
- b. the degree to which his movements were restricted
- c. his contact with other people
- d. his access to radio, television and reading materials such as newspapers and books
- e. the degree to which his actions were "observed"
- f. restrictions with regard to his food intake

3. Define Nosenko's present and past employment arrangements with the Central Intelligence Agency.

- c. itemized accounting of all compensation received by Nosenko

15. What was the CIA's position from 1964 to 1968 on whether Nosenko was telling the truth in the statements he made to the CIA about Oswald?

16. What is the CIA's position today as to whether Nosenko was telling the truth in the statements he made to the CIA about Oswald?

17. If the answer to question 15 is different from the response to question 16, when did the change occur and why?

18. Why were three polygraph tests given to Nosenko?

19. What is the CIA's position with regard to the validity of each of the three polygraph tests administered to Nosenko?

20. Why was Nosenko asked numerous questions pertaining to Oswald on his 1966 polygraph test and only asked two questions about Oswald on his 1968 test?

21. Who authorized Bruce Solie to reinvestigate Nosenko's bonafides?

22. Why was Nosenko's bonafides reinvestigated in 1968?

23. Did either the FBI or the CIA have primary responsibility for investigating Nosenko's statements
