1. VIEW AP ACCOUNT OF AMBUD MINISTERIAL APPOINTMENTS WHICH DESCRIBES ANYTIME AS HEAD OF "INVADING ARMY" REQUEST YOU IMPRESS UPON ALL WAVE PRESS CONTACTS NEED TO ELIMINATE "INVASION" OR SYMPTOMS FROM UTTERANCES OR ISSUANCES.
2. PRESUME THIS UNFORTUNATE RELEASE DERIVES FROM WITHIN AMBUD.
3. FYI: AMBUD-ONE IS NAMING A SPOKESMAN WHO WILL ACT FOR HIM AND AMBUD IN SAME WAY AS BLASINGER ACTS FOR PRESIDENT. HQS WILL BE IN CONTACT THIS YET UNNAMED SPOKESMAN WHO WILL IN TURN MAKE HIS RELEASES VIA LEM JONES ORG WHICH HAS BEEN SELECTED BY AMBUD AS THEIR SOLE LIAISON WITH THE PRESS. UNDERSTAND OSBORNE OF MAC LANEY, ADGES AND OSBORNE INVOLVED IN "ACCREDITING" CORRESPONDENTS TO GO TO CUBA. THIS IS OF COURSE HIGHLY UNDESIRABLE, AND WE ASSUME THAT OSBORNE ORG BEING USED UNLAWFULLY BY AMBUD-ONE TO ENHANCE LATTER IN PUBLIC EYE. LEM JONES WILL TELL OSBORNE THAT JONES ORG ONLY BE AUTHORIZED BY AMBUD REPRESENT ITS INTERESTS, AND HOPE THIS WORD CAN BE SPREAD.
