FOLLOWING IS SUMMARY DEVELOPMENTS ON EVACUATION MARCOS DIAZ LAZAR:

1. HERTCH TRAVELED HABANA-TAMPA AND RETURN 20-21 JULY AND REPORTED AMCOO AGREED EXFILTRATE SUBJECT 25 JULY. ARRANGEMENTS LAID ON WITH COURGE ON BASIS PATRICK I, KANEY WILL MEET BOAT TAMPA EARLY 27 JULY. COURGE FELT EDJUMP ASSISTANCE IN MIAMI NOT NECESSARY AND THEREFORE THEY NOT MADE WITING.

2. [BYERS] AND [WILLIAMS] CONTACTED SUBJECT NIGHT 19 JULY AND [BYERS] TO STATION HE IN GOOD SHAPE BUT EXTREMELY NERVOUS AND SCARED. CONTACT ARRANGEMENTS WERE SET UP BY [BYERS] WITH [CORME VILLATA ESPINOSA] FOR TRANSFER SUBJECT TO IMMEDIATELY (A CHARTER) WHO WILL TAKE HIM TO STATION SAFEHOUSE EVENING 23 JULY. AT STATION'S REQUEST MURKIN SPECIALISTS ON DOCUMENTATION AND DISCUSS ETD WASHINGTON FOR HABANA 22 JULY AND JOIN TAMPA MIAMI EARLY MORNING 23 JULY. TAMPA WILL CARRY DOCS AND KIT MIAMI-HABANA. STATION FEELS DELIBERATE ACCESS BY NEG SECURE TRANSFER SAFEHOUSE TO BOAT.

3. ⁰³ BYERS AND ⁰³ WILLIAMS ALSO REPORTED AFTER 19 JULY CONTACT THAT SUBJECT CONCERNED OVER SAFETY WIFE AND TWO DAUGHTERS AND WILLING SEND THEM MEXI BUT HAD NO FUNDS. HE UPSET SHE REFUSED PBPRIE VISA. STATION REPORTED WHEN SHE APPLIED FOR TOURIST VISA 8 JULY SHE WAS REFUSED BECAUSE OF SUBJECT'S "POLITICAL EXILE STATUS" (CONCLUDES UNWARE SUBJECT STILL IN CUBA) AND "INSUFFICIENT GUARANTEE" SHE WOULD RETURN CUBA AND NOT SEEK POLITICAL ASYLUM PBPRIE. STATION BELIEVES BEST WAY ASSIST FAMILY IS FOR EMBARK TO INTEREST NOW AT HQS FOR ISSUANCE PBPRIE VISA IN HABANA. HOWEVER, H'S BELIEVES PREFERABLE FAMILY GO MEXI AND H'S ATTEMPT OBTAIN ISSUANCE PBPRIE VISA IN MEXI AFTER SUBJECT'S ARRIVAL PBPRIE. H'S CABLED STATION MORNING 22 JULY IT BELIEVED PREFERABLE FAMILY GO MEXI BUT WOULD GIVE LETTER ANSWER SENSITIVELY.

4. H'S BELIEVES IT NECESSARY FOR SUBJECT'S SECURE EVICTION THAT HE BE ASSESSED PRIOR HIS EMBARKATION 25 JULY THAT FUNDS AVAILABLE ASSIST HIS FAMILY GO MEXI. IF CARRIED OUT, H'S PLANS CASE STATION LEAVE 23 JULY AUTHORIZING AMOUNT OF FUNDS (ESTIMATED BY STATION AT 1000 DOLLARS) FOR FAMILY TRAVEL AND SUBSISTENCE WOULD BE TRAVEL TO MEXI AND STAYING IN MEXI. H'S BELIEVES VISA FEES.
