04 1. FOR HAVA FYI ONLY: MANUEL RAY IN CONVERSATION WITH HEADER CLAIMED
[PADILLA] HIS ASSET. DESCRIBED [PADILLA]'S POSITION AS CITED REF. RAY HAD
PLANNED TIME DEFECTION OF ONE ISLE OF PINES GARRISON TO COINCIDE LIBERATION
MOTOS. WITH MATOS FREE AND REMAINING IN CUBA AND GARRISON ON LEFT CASTRO
SIDE RAY THOUGHT ISLE OF PINES COULD BECOME SIGNIFICANT BASE FOR ALL OPS.
MOUNTING ISLE OF PINES OP WOULD DEPEND MUCH ON OUR SUPPORT. FOR NUMEROUS
REASONS WHICH PRIMARILY POLITICAL AND TO BE REPORTED BY SEPARATE MESSAGE,
OUR RELATIONS WITH RAY GROUP STRAINED. ALSO WEP PLANNING FOR ABOVE OP STILL
NEBULOUS AND IT BECOMES CLEARER EVERY DAY THAT RAY CLAIMS SPECIFIC ASSETS
LOYAL ONLY TO HIM WHICH HE HAS NOT. REF APPEARS CASE IN POINT.

2. FOR MASH: TO FREE RUBEN MATOS VIA AMHAWK (AMRASP) AND ATTEMPT
STEER MATOS INTO AMRASP CAMP OF COURSE OF MUCH SIGNIFICANCE TO JMARC OBJECTIVES
GENERALLY AND AMRASP PRESTIGE SPECIFICALLY. THUS, STRONGLY BELIEVE WE SHOULD
PUT BEST FOOT FORWARD AND INFILTRATE MATOS IF REPORTS REF AND PARA (1) ABOVE
SUBSTANTIATED. SUBJECT TO HAVA COMMENTS SUGGEST AMHAWK BE CONTACTED AT ONCE
THIS REGARD AND BE ASKED HIS HAVA WEP ASCERTAIN ALL NECESSARY DETAILS.
