- ON 7 DEC PADBAYON/1 SENT TWO OF REF TELEGRAMS, ASKING FOR INVESTIGATION KENNEDY ASSASSINATION, TO PRESIDENT JOHNSON WITH DUPLICATES TO ATTORNEY GENERAL ROBERT KENNEDY. ONE TELEGRAM SIGNED "SIX LAWYERS OF DELHI BAR." SECOND SIGNED "SECRETARIAT FEDERATION OF INDIAN YOUTH."
- BLITZ REPEAT BLITZ, LINK REPEAT LINK AND NEW AGE REPEAT NEW AGE HAVE TAKEN LINE SIMILAR THAT SUGGESTED BY BOGDANOV. I.E. THEY DEMANDING PROBE OF ASSASSINATION.
