1. Reference is made to your memorandum of 19 May 1964, requesting that this Agency furnish any information in its files relative to Jack RUBY, his activities and his associates.

This memorandum will confirm our earlier statement to the Commission to the effect that an examination of Central Intelligence Agency files has produced no information on Jack RUBY or his activities. <The Central Intelligence Agency has no indication that RUBY and Lee Harvey OSWALD ever knew each other, were associated, or might have been connected in any manner.>
