1. [⁰¹NIEKIT-3] REQUESTED STATION MEXI AID IN EXPEDITING VISA REQUESTS FOR [⁰⁶PESTARINO] AND WIFE WHO NOW WORKING [⁰¹NIEKIT] EMB ASSY HAVA AND BEING TRANSFERRED TO CONGEN N.Y.C.

2. ODACID HQS CABLED AUTHORIZATION TO PBSWING MEXI BUT LOCAL OFFICER CANNOT ISSUE PBPRIME VISA UNLESS IN RECEIPT OF ADDITIONAL CABLE FROM ODACID HQS TO FOLLOWING EFFECT:

"NOT WITHSTANDING THE CONTENTS OF THE (ODACID'S) OMV'273, DECEMBER 24, 1963, AND OTHER INDICATION THAT [⁰⁶PESTARINO] IS POTENTIAL IMMIGRANT THE (ODACID) RECOMMENDS IMMEDIATE ISSUANCE A-3 VISAS FOR MR AND MRS [⁰⁶PESTARINO]."

3. [⁰¹N-3] FEELS FITTING JUSTICE THAT KUBARK ASSIST, BUT MEXI LEAVES TO HQS AND WAVE DISCRETION WHETHER OR NOT OVERTURES SHOULD BE MADE TO ODACID LIAISON ON THIS MATTER, NOTE THAT MEXICAN VISA UNAVAILABLE WITHOUT PRIOR PBPRIME VISA. [⁰⁶PESTARINO] SUBJECT TO CUBAN ARMY DRAFT AFTER 1. JAN 64. ADVISE MEXI YOUR DECISION.
