16. COMMENT: "CIA claimed it did not know of most of OSWALD's activities in Mexico City until after the assassination." This is true; however, it should be pointed out that after the dissemination on 10 October of the 1 October 1963 contact no requests were received from the recipients of the report for further information or follow-up investigation. Under the Delimitations Agreement, OSWALD, as a former Marine, was a Navy and FBI case and potentially of interest to the Department of State.

In interviews with The Post, Belin, who documented the CIA plots against Castro in his capacity as executive director of the Rockefeller commission, revealed the CIA also did not tell the Warren Commission of a report from an alleged witness to a meeting in Mexico City between Oswald and Cuban intelligence agents.

17. COMMENT: Is BELIN referring to Gilberto ALVARADO Urgate? If so, information regarding OSWALD provided by ALVARADO was passed to the Warren Commission as attachments to a memorandum for J. Lee RANKIN, dated 1 June 1964, from Richard HELMS, Deputy Director for Plans.
