1. A. MECHANICS OF LATERAL POUCH TO PERUEN: LETTERS AND PACKAGES WRAPPED AND SEALED CLASSIC MANNER, ENVELOPED IN CANVAS POUCHES WITH 30 X 40 CENTIMETER OPENING. POSSIBLE, HOWEVER, SEND LARGER PARCELS IF NECESSARY. IT THE USUAL FREQUENT SEND ITEMS ADDRESSED TO PRIVATE INDIVIDUALS PERUEN.

B. LIMITATIONS OF USE: NO LIQUIDS OR EXPLOSIVES.

C. FREQUENCY: IN EFFECT THERE ARE TWO POUCHES MONTHLY; FOR EXAMPLE ON 13 DEC, ONE OFFICER STATIONED MEXI WILL TAKE POUCH PERUEN, RETURN WITH POUCH FROM EMBASSY PERUEN. APPROXIMATELY TWO WEEKS LATER, OFFICER FROM EMBASSY IN PERUEN WILL COME MEXI AND REPEAT PROCESS. NO PLANNED CARRIER ROSTER
