1. AMSEVER-2 REPORTS SUBJ HAS REPLIED TO LATEST LETTER FROM BROTHER MEXI INDICATING WILLING REMAIN IN PERUMEN. WILLING SUPPLY ANY INFO TO WHICH HAS NORMAL ACCESS, ABLE USE [NETHERLANDS] POUCH FOR COMMO, REFUSES TO HAVE CONTACT WITH "ANY KUBARK OR ODENVY PEOPLE" INSIDE PERUMEN. LETTER STATES "YOU HAVE NO IDEA WHAT THINGS ARE LIKE HERE, PEOPLE SHOT EVERY DAY, I AM SURE I AM BEING WATCHED."

2. DURING PAST WEEK STATION C/O MET BY CHANCE CLOSE FRIEND FROM CARACAS DAYS, 1949-1952, [JAMES BONNER] PPRIME CITIZEN, ATTENDING RECENT INSURANCE CONFERENCE MEXI. [BONNER] NOW RESIDENT PUERTO RICO, KNOWS BROTHER WELL SINCE BOTH WORKED FOR SAME INSURANCE COMPANY. SAYS BROTHER FINE PERSON, VERY PRO-PPRIME. [BONNER] SAW BROTHER AT CONFERENCE AFTER FIRST ENCOUNTER WITH C/O AND LEARNED THAT BROTHER ANXIOUS ARRANGE PPRIME VISAS FOR PERUMEN FRIENDS OR RELATIVES. [BONNER] GAVE BROTHER NAME OF C/O WHO CONSUL AND THIS PRESUMABLY INVOLVED VISA MATTERS. BROTHER SAID WOULD LOOK UP C/O SOON. PLE NOTE THAT [BONNER] UNWARE ANY OPERATIONAL INTEREST IN BROTHER OR SUBJ.
