PACKAGE LIFECYCLE MATERIALS, AND IF TOPIC ARISES SHOULD REFER SUBJECT TO LATER
DISCUSSION WITH PEPRIDE CO. DETAILS FOLLOW THROUGH KIDUSS/D CHANNELS.

4. ALTHOUGH RECOMMENDED STRONGLY PREFERRED, IF INTEREST ONLY
ALTERNATIVE, STATION CANNOT GUARANTEE SUBJECT PEPRIDE RESIDENCE STATUS BUT CAN
