- SEE REF B HQS GENERAL POSITION AMBIDY VENTURE.
- FYI BENDER HAD HELD OUT HOPE AND FAVORED AMBIDY RETURN. HOWEVER THIS PRIOR RECENT TEMPORARY SETBACKS: ABORTIVE DROP, AMPANIC FIVE ARREST, ETC. WHILE NOBODY INTENDS IMPLY WE SHOULD PULL HOME IN, FEELING HERE THAT AMBIDY INFIL GREAT SECURITY RISK IN ADDITION OTHER FACTORS REF B.
- PERHAPS TWICKER AND OTHERS CAN PERSUADE AMBIDY TAKE WAIT AND SEE POSITION IN LIGHT PUBLISHED REPORTS ESCAMERAY DIFFICULTIES.

WH COMMENTS: * AMBIDY informed TWICKER he planning return Cuba with or without help; was very keyed up and tense.
** Hqs agreed in principle to infil but felt time not right and would be too much of security risk.
