EXAMINATION OF PASSPORT APPLICATION INDICATED THAT SUBJ STARTED TO PUT SEPARATED UNDER MARRIAGE STATUS THEN CROSSED IT OUT AND INDICATED THAT MARRIAGE NOT TERMINATED. AS OF JUNE 61 SUBJ WAS WORKING UNDER LICENSE OF THE ACCURATE DETECTIVE LABORATORIES.
