- COORDINATOR CUBAN AFFAIRS CONCERNED BY AMCORE-2 EXPLOITATION OF ESSENTIALLY CASUAL CONTACT WITH SECRETARY RUSK TO PRESSURE FOR INCLUSION CUBAN PROBLEM IN AGENDA FOR LATIN AMERICAN SUMMIT MEETING. DEPARTMENT HAS SENT CIRCULAR MESSAGE TO EMBASSIES ADVISING THAT U.S. NOT PRESSING FOR INCLUSION CUBA ON FORMAL AGENDA. AMCORE-2 PLACING DEPARTMENT IN SITUATION WHICH MAY NECESSITATE PUBLICLY DISAVOWING HIS CLAIMS, WHICH COULD RESULT IN DAMAGE TO HIS PRESTIGE AND USEFULNESS.
- REQUEST STATION MAKE FORCEFUL PRESENTATION ABOVE TO AMCORE-2 AND DIRECT HIM CURTAIL HIS EXPLOITATION OF CONTACT WITH SECRETARY RUSK.
