- PRELIM REPORT FROM AMSWIRL 1 IN KEY WEST INDICATES CO-PILOT PEDRO SARRIA MENDIATE MAY WISH RETURN CUBA. REASONS NOT CLEAR.
- SUMM COMMUNICATED PARA 1 INFO HIS HQS WASH WHICH INCLINED ADVISE CZECHS PM 13 OCT THAT PLANE LANDED AND SARRIA MAY WISH RETURN CUBA. HAVE EXPRESSED OPINION TO SUMM THAT WE ILL ADVISED TELL CZECHS ANYTHING ABOUT SARRIA INTENTIONS UNTIL HE INTERVIEWED BY EXPERIENCED DEBRIEFER IN MIAMI AND WE ABLE DEAL WITH FACTS AND NOT CONVERSATIONAL TIDBITS WHICH PASSED IN DOUBLE TALK BY TELEPHONE FROM KEY WEST TO MIAMI. SUMM AGREED TRY PERSUADE HIS HQS TELL CZECHS NOTHING UNTIL AM 14 OCT.
- 1930 HOURS 13 OCT SUMM ADVISES THAT HIS HQS HAS AGREED LIMIT 13 OCT DISCUSSION WITH CZECHS TO SIMPLE STATEMENT THAT AN-2. PLANE LANDED U.S. TERRITORY.
- HOPE HAVE BOTH MEN WAVE CUSTODY CIRCA 2300 HOURS 13 OCT FOR DEBRIEFING. WILL HAVE DEBRIEFING WRAP-UP READY LEAVE WAVE 0900 HOURS 14 OCT.
