1. SUBJECT REF IS PRESENTLY NOT KUBARK CONTACT AND HAS NO KUBARK MISSION.
2. HQS HAS FOLLOWING TRACES SUBJ:
  - A. DPOB: 26 AUGUST 1937, CARDENAS, MATANZAS, CUBA.
  - B. ARRIVED PEPRIDE 2 MAY 1960. WAS GRANTED POA 18 OCTOBER 1960 FOR PARTICIPATION OF AN ANTI-COMMUNISM BOY BUT WAS TERMINATED 20 MARCH 1961 AS MALCONTENT. KUBARK HAS HAD NO CONTACT WITH SUBJ SINCE.
  - C. IN JULY 1963 SUBJ WAS INVOLVED WITH THE PURCHASE AND CASHING OF 2400 POUNDS DYNAMITE, 100 POUNDS PRACTICE BOMBS AND OTHER RELATED MATERIAL AND PLOTTING BOMB BUILT OIL CO AND OTHER TARGETS PERUBOH. SINCE COENY FELT APRIAL ATTACK PERUBOH HAD BEEN EFFECTIVELY THWARTED BY SEIZURE OF AIRCRAFT AND IMPROBITY OF AIRCRAFT NO ORIGINAL ACTION CONSIDERED AS TARGET AGAINST SUBJECT AND HIS CONTACT.
  - D. ON 16 APRIL 1965 SUBJECT VISITED GEORGE AND STATED HE PLANNED TRAVEL SPAIN LATE APRIL OR EARLY MAY 1965 TO VISIT GRANDMOTHER WHO EMIGRATING THERE FROM PERUBOH. CLAIMS HE RECENTLY HEARD FROM FRIEND, LEONEL ALOP'S FIEL,

ALLEGEDLY PERUGEN AND MEROCCO WHO WOULD BE OF INTEREST KIBARK. SUBJECT  
 CLAIMS HE WOULD GLADLY TRAVEL NORTH AFRICA PERUGEN ALTHOUGH IF KIBARK DESIRES  
 BUT DOES NOT KNOW HOW CONTACT KIBARK AT PRESENT. COURGE FEELS SUBJ MAY NOT  
 ONLY WANT KIBARK FINANCIAL HELP THIS TRIP BUT ALSO HOPES KIBARK WILL OVERCOME  
 HIS RE-ENTRY PERCENT DIFFICULTY WHICH HE FACES. ALSO DURING THIS VISIT SUBJ  
 TOLD COURGE HE RECEIVED KIBARK TRAINING GUATEMALA, IS DISSOLUTION EXPERT,  
 HAS MADE SEVERAL ILLEGAL TRIPS PERUGEN, TOOK PART IN ACTIVITY AGAINST PERUGEN  
 IN STRIKE 1962, AND HE REVERED ALL KIBARK AND ANTI-AMERICAN CONSPIRACIES 1962.

3. SUGGEST FOIL ACTION:

A. HAVE NO CONTACT WITH AND GIVE NO ASSISTANCE SUBJ.

B. CAUTION [USRAFU/9] HE SHOULD NOT BECOME INVOLVED WITH TALKATIVE  
 PERUGEN KIXLES, PARTICULARLY PEOPLE FROM OR WHO HAVE CONTACTS JMWAVE AREA  
 SINCE THEY PROBABLY HEAVILY ANCHOR/1. PERUGEN, AND AS THIS WILL ESPECIALLY LEAD  
 TO REPRODUCTION AM/AM/1.

C. REQUEST [USRAFU/9] ELICIT WHAT OTHER HIGHLY PLACED CONTACTS  
 SUBJECT MAY HAVE IN EUROPE OR NORTH AFRICA AND INFO RE PERUGEN ACTIVITY.
