MEMORANDUM OF ORAL COMMITMENT

TO : Deputy Chief, WH/SA

SUBJECT: Engagement of Identity A 201 251853

1. Term and Project Charge. The subject individual has been engaged under oral contract for use under TYPIC and is to be charged against PM cost center. The effective date of the oral contract is 1 February 1965 and it shall continue until terminated by either party upon fifteen days actual notice.

2. Security Approval. The appropriate security approval, to utilize Subject as requested, has been obtained.
OA granted 4 April 1963 per UFGW-1807 13 April 1963

3. Citizenship. The Subject is a Cuban Refugee and was born on 7 Aug 1918 at Santiago de Cuba, Oriente Province and resides Identity C

4. Compensation. Commencing on the effective date of this agreement, Subject will be paid compensation at the rate of \$ 750.00 per month. Such payments to be made following completion of satisfactory service.

5. Taxes. Subject will be obligated to pay U.S. income tax. Taxes will not be deducted from the above stated paid compensation. Subject is not eligible for Social Security. Subject is married and has a total of 4 dependents other than himself.

6. Quarters and/or Subsistence. The Subject will not be furnished quarters and/or subsistence.

7. Operational Expenses. Subject will be reimbursed for:

a. \$100.00 per month for Operational Mileage claims for use of personal automobile.

b. When properly authorized hotel expenses, meals, telephone calls etc. will be paid Subject.
