1. AIR FORCE INTELLIGENCE ADVISES THAT MAJ. BERNARD F. REHKOPF, USAF ASSIGNED TO MACTHAI, HAS BEEN IN TOUCH ASKING ASSISTANCE IN CONTACTING AN LNERGO OFFICIAL. 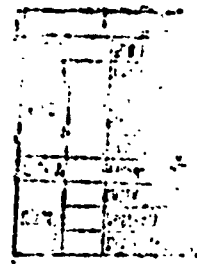
