Subject: (LITAKIL-9) of



On 25 Feb 63, PARRIZO and I picked up (LITAKIL-9) at rendezvous point and we drove to a darkened area of the city where meeting was held. NO SECURITY INCIDENTS NOTED. Time: 2170-2245

(LITAKIL-9) provided the following info:

1. Irina TRAFOTE de VALDES, wife of Ramiro VALDES, Sec Gobernacion in Habana is scheduled to leave for Habana on 1 Mar 63.

2. ~~Manuel~~ <sup>ff 201-334253</sup> VEGA Perez, Cuban G-2 in Mexico told a group of Cubans in the Cubana plane on 25 Feb that he has been in Prague on two occasions. <sup>201-334253</sup> ~~DO1 FEB 63~~

3. <sup>see 201-334253</sup> ~~Margalena~~ <sup>CIT. MEXICO, MEXICO CITY</sup> GARCIA, Mexican wife of Humberto GARCIA told (L-9) <sup>CIT. MEXICO, MEXICO CITY</sup> on the phone that Antonio ~~Mico~~ GARCIA had a message for her. (L-9) queried GARCIA re same and GARCIA told (L-9) that he did not have a message from anybody for Margalera GARCIA.

4. On 25 Feb 63, (L-9) said that two valijas left Mexico for Habana. He said that the lightest one carried confidential reports. <sup>CIT. CUBA?</sup> He said that ~~Manuel~~ <sup>Ramirez</sup> SANCHEZ put two confidential reports in the pouch in his presence. <sup>CIT. MEXICO, MEXICO CITY</sup> ~~RE-AC~~

5. (L-9) said that Pilar, Ina, stewardess and two others were arrested and sent to a farm formerly owned by BATISTA where they will spend from 1-2 years. The three were charged with contraband operations on MAVA-MEXI flight. According to the report, 10,000 dollars worth of jewels were found in the back of a plane next which returned to Havana from Mexico. It appears that the jewels were not taken off the plane in Mexico as planned.

6. (Dr.) Angel <sup>CIT. MEXICO</sup> MARTINEZ Chando, Mexican <sup>see</sup> biochemist, left Mexico for Habana on 25 Feb 63. MARTINEZ told (L-9) that he hoped to be named <sup>DO1 FEB 63</sup> honorary Consul in Santiago de Cuba where a Spaniard is currently holding the job. According to MARTINEZ, the Spaniard is not in the Gov't's good graces and he hopes to replace him.

7. (L-9)<sup>ol</sup> has heard nothing of importance re AMBASSADOR visit from Cuban dips. On 25 Feb the following group had coffee on board the Habana plane: Antonio "Rico" GARCIA, Manuel VERAIXX Per6z, ~~LUIS PEREZ~~ Eusebio AZCUE Lopez, Benigno CASTELLAR Sanchez, Andres ARACENA Ramos and (L-9)<sup>ol</sup>. The group was very angry because of the new stamp that the Cuban Gov't is using at the airport. All passports are now being stamped by Immigration officials as follows: SALIO A CUBA or LIEGO DE CUBA. This stamp is placed on the page where the Subjects photo is found. The group said that as soon as the Ambassador arrives he should squawk loudly to the Mexican Govt about this.

8. Eusebio AZCUE Lopez, Cuban Consul, was upset because now all Cuban cables pass through New York. He remarked: "Les estan dando todo en bandeja de plata". *Dec 1963*

9. On 25 February 1963, Cora SOLOZANO, sister in law of Genl Lazaro CARDENAS called Ramon SINOBAS Casado "un pendejilloz incorruptible". SOLOZANO is the god-mother to one of SINOBAS' children. SOLOZANO also remarked that Julio ARGUELLES, who is a partner of Cuauhtezcoc CARDENAS, cannot understand what is the matter with the Cuban Govt letting the Embassy "go to rot", i.e. lack of personnel decente y adecuado. ARGUELLES, according to SOLOZANO, said the Cuban Govt officials "no se dan cuenta lo que significa Mexico". Eusebio AZCUE, who was with (L-9)<sup>ol</sup> during his conversation with her at her gas station, defended SINOBAS saying "Nosotros en cu cada lo haríamos peor, es la culpa de MEXICO".

Memorandum for the Record

Subject: (LITAMIL-9) 01

On 27 Feb 63, I met (LITAMIL-9) at rendezvous point and we drove to darkened street behind my home, where we held mtg. NO SECURITY PROBLEMS NOTED. Time: 2200-2300. (L-9) and I then went to my house where we talked at great length with PARTERS re (L-9)'s assignment.

LITAMIL-9 provided the following information:

- On 21 Feb 63, (L-9) attended the inauguration of Exposition at the Bellas Artes. Pres LOPEZ Mateos also in attendance. (L-9) saw SEN. MORENO HENESTROSA and Dolores DE LA MORA Zecada also. (L-9) told DE LA MORA he was returning to Cuba and would be happy to take a letter with him for her. At 1645 (L-9) visited DE LA MORA at her home. DE LA MORA told (L-9) that she was very worried about Csta, i.e. with the recall of Soviet troops, arrival of BENTACOURT in Mexico etc. Sen. MORENO said that she told LOPEZ Mateos that she not proud of being a Mexican because of the Gov't's anti-CASTRO attitude. She cited the activities at the airport as an example. She told LOPEZ to tell LOPEZ that "la barrera que te rodea te impide conocer la verdad". DE LA MORA told (L-9) that she saw LOPEZ Mateos after this and he said that following to her in a sarcastic manner: "Te felicito... no eres Mexicana". Tu amigo "palele", no lo tuvieron presente pasada crisis, mientras Mexico sosteniendolo principio "no intervencion". DE LA MORA said that her father will accompany Pres. LOPEZ Mateos on his trip to Europe. DE LA MORA told (L-9) that Sen. MORENO Sanchez considers it very important that Cuba have an

2. (LITANIL-9) said that Eusebio AZCUE, Cuban Consul, said that a new Amb was coming to Mexico. AZCUE said that LUCHENA would come to Mexico but only to say goodbye before leaving for his post in the United Nations.

3. AZCUE told (L-9) that Rafael DEL RIO former 1st Sec Mexico, and G-2 man, told AZCUE that he did not believe that (L-9) was integrated into the Revolution. ("no te considera integrado a la Revolucion") (FEB 63)

4. Pedro LARA Munoz has been transferred to Chile (already has ticket) and SARDINAS, fru is coming to Mexico from Bolivia (direct transfer).

SARDINAS is probably Antonio SARDINAS Garcia listed in the Foreign Service Bulletin - Jan 63. CIT: CUBA A BOLIVIA OCC DIPLOMA

5. On 22 Feb 63, Antonio MONTEAGUDO, Cuban business man (pharmaceutical) and close friend Rev arrived in Mexico from Habana. MONTEAGUDO remarked to (L-9) "Todavia no nombraron nuevo Embajador". This another indication that a new Amb will be named to Mexico. CIT: CUBA RE COMMITMENTS BY SUBJ. ON NEW CUBAN AITA TO MEXICO DOI FEB 63

6. A Cuban courier (negro) arrived on 22 Feb "in transit". Two pouches arrived for the Emb in Mexico.

7. The wife of AMSTER-1 arrived in Mexico on 22 Feb without the children.

8. Clara PORSET de CUERRERO, Cuban, arrived on 22 Feb from Habana.
