2. FOR LIMA, QUITO: IF POSSIBLE DETERMINE WITHOUT DISPLAYING UNDUE INTEREST IN AMBUD, WHAT WAS NATURE OF ACTIVITY SUBJ WITH ECUADORANS WHICH PIP STATES IS REASON FOR DEPORTING HIM FROM PERU.
