1. REQUEST MARBON CONTACT LICARI SOONEST AND TRANSMIT FOLLOWING:

FYI ONLY AND NOT REPEAT NOT FOR CUBANS ODYOCE CUBA WHITE PAPER WILL BE ISSUED 29 MAR AND CUBAN PAPER SHOULD PRECEDE IT. ODYOCE PAPER WILL BE DEALING WITH PAST AND CURRENT CASTRO REGIME SINS.
