1. ASSIMILATION OF AMIRCS BY AMBUD HAS CREATED AREAS OF BUDGETARY CONFUSION WHICH HEADQUARTERS DESIRES ELIMINATE. TO THIS END REQUEST PASSAVOT ASK AMBUD-1 FOR DOSTER MEXI DELEGATION AND HIS PLANS FOR FLEETING. AMBUD-1 PROGRESSIVELY HAS EXPRESSED VIEW THAT FUNDS FOR ALL EXILE ACTIVITIES BE DISBURSED THROUGH HIM. INsofar AS AMBUD AFFILIATES ARE CONCERNED HEADQUARTERS ENDORSES THIS PRINCIPLE, AND AGREES HE WILL PAY SALARIES OF ALL OVERSEAS DELEGATIONS, INCLUDING MEXI, FROM BASIC ADMINISTRATIVE BUDGET. SUPPLEMENTARY FUNDS MAY BE PROVIDED FOR COSTS OF OPERATIONS WHICH APPROVED BY HEADQUARTERS. THIS APPLIES TO OPS UNDERTAKEN BY OVERSEAS DELEGATIONS WHICH SHOULD SUBMIT PROPOSALS TO AMBUD FOR SUBMISSION KURAEK VIA PASSAVOT.

2. AFTER AMBUD-1 AGREEMENT OBTAINED ON ABOVE PROCEDURES REQUEST WAVE ADVISE MEXI NAME OF MEXICAN DELEGATION AND COORDINATE WITH MEXI RE TIMING OF INITIATION FUNDING BY AMBUD AND PROVISIONS OF TERMINAL PAY FOR THOSE DROPPED.

3. FOR MEXI: AFTER RECEIPT AMBUD ROSTER ADVISE IF ANY PLANS FOR INDEPENDENT USE OF PERSONS DROPPED BY AMBUD.
