PLEASE HAVE SCANTLING WRITE LETTER ENCODING FOLLOWING IDEAS:

EXCELLENCE

AS YOU MAY KNOW FOR SEVERAL MONTHS I HAVE BEEN ENGAGING  
IN PURCHASING VARIOUS COMMERCIAL ITEMS FOR MR. SIOBAS AND MR.  
VEGA OF YOUR EMBASSY. FOR A NUMBER OF MONTHS THESE PURCHASES WENT  
VERY WELL AND I BELIEVE BOTH YOUR GOVERNMENT AND I WERE SATISFIED  
WITH THE ARRANGEMENTS AND DELIVERIES.

SINCE THE DEPARTURE OF MR. SIOBAS AND MR. VEGA, HOWEVER,  
I HAVE NOT BEEN ABLE TO CARRY ON MY BUSINESS WITH THEM IN A REGULAR  
MANNER. I HAVE GONE TO MUCH TROUBLE TO GATHER ARTICLES THAT  
THEY WERE INTERESTED IN AND TO DELIVER THEM AS INSTRUCTED; YET,  
NOW THREE WEEKS AFTER MAKING MY LAST DELIVERY I HAVE STILL NOT  
BEEN PAID.

I OBJECT TO THE GREAT DELAYS IN MAKING PAYMENT TO ME AND  
REQUEST THAT MR. SIOBAS OR HIS APOCRADO IN THIS CITY BE INFORMED  
THAT I HARDLY NEED THE MONEY AND CANNOT MAKE FURTHER DELIVERIES UNTIL  
I HAVE RECEIVED MY DUE PAYMENT.

"I ALSO REQUEST THAT THIS LETTER BE ANSWERED AS SOON AS POSSIBLE AND I HOPE NEITHER YOUR GOVERNMENT NOR I WILL BE CAUGHT UNPREPARED IN THE EVENT THE AMERICAN NATIONS ALL BREAK RELATIONS WITH CUBA.
