<p>The material obtained from the Immigration and Naturalization Service pertaining to Lee Harvey OSWALD's spouse Marina was provided to Mr. <del>SMITH</del>, in the office of Mr. <del>BLANKENHORN</del> CI Staff, on 27 November 1963 with the understanding that it would be returned to the Office of Security when CI Staff is finished with it.</p>		
<p>On 23 January 1964, Mr. <del>SMITH</del> advised that they are still using the material; however, they intend to return it to the Office of Security when they have finished their interest.</p>		
<p>All material numbered 75 149 - 625, in the name of Marina N. OSWALD, has been transferred to the file of Lee Harvey OSWALD, #351 164, with the exception of the material in the possession of the CI Staff, which, when returned, will be placed in #351 164 also.</p>
