

SUBJECT: JFK Assassination Records

Per your request, attached are the two documents referred to in the JFK Assassination Board's letter to the Director of 31 July 1995. The sole remaining issue concerned the release of the cryptonym "LIENVOY". All other issues have been resolved. We are discussing with the DO the question of whether to appeal. In my view, we are unlikely to appeal.

1. [LIENVGY] REPORTED 15 JUN 65 THAT UNIDENTIFIED WOMAN SPEAKING FRENCH CALLED CUBAN AMBASSADOR HERNANDEZ ARMAS FROM CHICAGO ON BEHALF OF A MR. GAN (PHON) ASKED IF SILVIA DURAN WAS FRIEND OF LEE OSWALD AND IF SHE HAD RETURNED TO CUBA.
