NATURALLY, SHE SHOULD INSURE THAT HE WILL BE AT END WHICH ATTEMPT FOR AMER-1  
BUT BEFORE THIS IF REALLY REPEAT REALLY DESIRED AMER-1 AND REALLY REPEAT  
UNDERSTAND THE INSTRUCTIONS THE CASE REGARDING TO APPEAR SUBSTANTIAL CLARITY. FACT  
THAT AMER-3 IS MEMBER OF TELEPHONE CALLS FROM WIFE AND IS PRINCIPAL STATION
