1. KEY ISSUE SIBO SOVIET DISPUTE IS CHICOM REFUSAL SIGN NUCLEAR TEST BAN TREATY. HQS PLANING SERIES BLACK OPS EXPLOIT THIS SITUATION TO REACCELERATE FURTHER SIBO SOVIET RELATIONS AND DISRUPT NATIONAL CP'S AND FRONT'S PARTICULARLY THOSE ATTEMPTING WALK TIGHT ROPE OF "WAR AND PEACE" ISSUE IN SIBO SOVIET IDEOLOGICAL DEBATE. AS PART OVERALL PLAN CHECK WHETHER MEXI CAN ARRANGE DEMONSTRATIONS AGAINST CHICOMS DURING TRADE FAIR. VISUALIZE TYPICAL COSSIE "BAN THE BOMB" DEMONSTRATIONS EMPLOYING PICKETS AND DISTRIBUCTION LITERATURE CONDEMNING BOTH CHICOMS AND CURASS FOR FAILING JOIN "PEACE LOVING PEOPLES OF THE WORLD" TO ELIMINATE THREAT NUCLEAR WAR.

2. WOULD BE PREFERABLE IF ACTUAL PRO-MOSCO COSSIE GROUP PER REF <sup>A</sup> COULD BE PROMPTED ORGANIZE DEMONSTRATION. IF THIS NOT POSSIBLE SUGGEST MEXI UNDERTAKE ORGANIZE DEMONSTRATION USING MERCHANTS. HQS PREPARED SUPPORT BY PROVIDING LITERATURE AND OTHER MATERIALS, IF NECESSARY.
