WHOM WE OBTAINED THESE PHOTOS IS [STILL ACTIVE AND SENSITIVE.] (S)

WE ASSUME THAT ANY ATTORNEYS OR INVESTIGATOR EXAMINING THESE  
CROPPED PHOTOS WOULD WANT TO LEARN, UNDERSTANDABLY, WHERE

AND WHEN THEY WERE TAKEN. SUCH INQUIRIES COULD LEAD TO THE  
COMPROMISE OF OUR SOURCE. FOR THIS REASON, THEREFORE, THE

PHOTOGRAPHS CANNOT BE RELEASED AS REQUESTED IN YOUR MEMORANDUM  
OF MAY ONE FIVE ONE NINE SEVEN TWO. UNQUOTE.

CROPPED PHOTOS IN POSSESSION OF LEGAT, MEXICO, NOT BEING  
SUBMITTED IN ABSENCE OF FURTHER INSTRUCTIONS FROM BUREAU.
