It is noted that all pertinent information furnished by CIA, Mexico, concerning ZHENYA DEYMONSHUIK, aka JEANE XLIGON DE MOHRENSCHILDT, who appears to be identical with JEANNE DE MOHRENSCHILDT, has previously been furnished to the Bureau.
