LIEUTENANT, U.S. ARMY, AND SOUETRE WAS ASSIGNED WITH FRENCH FOURTH AIR FORCE. ALDERSON ADVISED HE HAS SINCE OCCASIONALLY CORRESPONDED WITH SOUETRE, USUALLY IN FORM OF CHRISTMAS CARDS, BUT HAS NOT RECEIVED CORRESPONDENCE FROM HIM FOR MORE THAN YEAR.

THERE ARE NO DIRECT FLIGHTS BETWEEN HOUSTON AND CANADA. NO RECORD LOCATED FOR SUBJECT AT PAN AMERICAN AIRWAYS, HOUSTON, WITH REGARD TO FLIGHTS TO MEXICO CITY DURING PERIOD NOVEMBER TWENTY-THREE TO TWENTY-FIVE LAST.

BUREAU HAS NOT INITIATED ANY INQUIRIES IN CANADA OR MEXICO, IT BEING ASSUMED FRENCH AUTHORITIES WILL MAKE THEIR OWN ARRANGEMENTS IN THIS REGARD.] (C)

FOR YOUR CONFIDENTIAL INFORMATION, BUFILES REFLECT SOUETRE, AS REPRESENTATIVE OF OAS, [WAS IN CONTACT WITH CIA AGENTS IN LISBON DURING MAY, ONE NINE SIX THREE.] SUBJECT WAS SEEKING U.S. SUPPORT FOR ANTI-DE GAULLE ACTIVITIES. [THIS DATA NOT TO BE FURNISHED

[REDACTED] HOWEVER, YOU SHOULD SUGGEST THAT IF NOT ALREADY DONE, [REDACTED] MAY DESIRE TO CONTACT CIA.] (X)

NOTE: [Subject, former French Army officer who deserted and who is now reported to be militant member of Secret Army Organization (French terrorist group), is of interest to French authorities. This stems from fact that French have received information that subject was in U.S. in late 1963 and left for Mexico coupled with fact that President DeGaulle plans to visit Mexico in mid-March.] We are conducting inquiries re subject as police cooperation matter. (C)
