The memorandum is classified "Confidential" because it contains information from NY 4047-S*, a sensitive source.

The Washington Field Office is requested to contact the Passport Division, U. S. Department of State, to determine the status of the subject's passport application.

Since the possibility exists that the subject may be going to Israel for other purposes than to accompany her father and since these other purposes may be quite significant in determining the scope of her Chinese Communist activities, the Bureau is requested to consider contacting the U. S. Department of State so that the subject may receive her passport. Her activities in Israel may then be covered by CIA. (S) X

It is to be noted that Israel maintains diplomatic relations with Peking, and it would be quite significant if the subject contacted the Chinese diplomatic establishment in Israel. (S) (u)
