For information of the Bureau, informant personally attended the press conference with OSCAR ANGULO BEYES, a Cuban newspaperman. Prior to the conference, ANGULO told informant that he himself had prepared a report for BOSCH so that BOSCH could hold a press conference and claim credit for the information contained in the announcement. ANGULO told informant he had received the information concerning the alleged missiles from various Cubans he had interviewed in the Miami area after their arrival from Cuba, and had combined it with information recently announced by former Ambassador BRADEN. Informant said that during BOSCH's press announcement, ANGULO regarded the incident as something of a joke.

On 11/12/65, [HARRY RANDALL] CIA covert (protect), advised this office that ANGULO was of operational interest to CIA.

No reference has been made to ANGULO in the attached LHM in order to protect MM 635-S.
